3. OBJECTIVES:

- a) To establish, promote, setup, run, maintain, assist, finance, support and / or to help in the setting up / or maintaining and/or running Colleges and Educational institutions for the children and the women particularly and the poor, old, infirm and destitute in general.
- b) To give provide and/or render help and assistance in cash or kind to poor and destitute people and widows etc.
- c) To give provide and/or render help and assistance to and/or implement any schemes for providing Education to the girls & boys.
- d) To impart various types of technical and professional education through vocational training centres.

- g) To promote advance and encourage and/or in helping, promoting, advancing and encouraging, higher education and technical and medical education also physical and vocational training and other useful arts, crafts for women and the needy persons and other welfare centres for them.
- h) To foster and encourage education and training in handicraft, fine arts, among women, folk in general and establish institutions for imparting such education and establish institutions for imparting such education and to establish maintain, support or help by monetary gifts or otherwise for women and children and to provide social welfare works for the students.
- i) To grant pay or give scholarship, stipends, prizes, rewards, allowances and other financial assistance or help in cash or kind to students with a view to help them in prosecuting their studies in colleges educational like for the running of welfare and other services.


- k) To set up or embark any line of work for the development and upliftment of the people in general, irrespective of caste, creed and religion.


- 4) The Financial year of the Trust shall commence from $1^{\rm st}$ April every year and shall close on $31^{\rm st}$ March.
- 5) The Trustees may accept any donation or contribution in cash or kind from any person, firm, company, corporation, associations, institutions and the Government for furtherance of the objects of the trust. The trustees may take over the management of any other charitable or public institutions on such terms and conditions as they think fit and may manage such institutions.
- 6) To arrange for and/or authorise the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustees by any two of the trustees to be nominated on this behalf by the Board of Trustees.
- 7) To appoint the sub-committees if need be so to attend or supervise or conduct specified jobs.
- 8) The trustees shall cause true and accurate accounts to be kept of all moneys received and spent.

- 9) The trustees shall keep an account or accounts in Nationalised or non-nationalised bank or with any banks and to operate such account or accounts and to authorise by appropriate resolution two or more of the trustees jointly to operate such account or accounts.
- 10) The trustees may establish its office at such place or places, and may change such place from time to time as they may think fit.
- 11) The trustees shall have full powers to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the trust estate and/or the trust properties and to refer any such differences or disputes to arbitration.
- 12) The trustees shall have full powers to compromise or compound all actions, suits and other proceedings and settle differences, and disputes touching the trust estate and/or the trust properties and to refer any such differences or disputes to arbitration.
- 13) The minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by all the trustees present in the meeting, which shall be conclusive evidence of the business and other matters transacted at such meeting.





- 22) A trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of his opinion shall be taken as his vote on the matter concerned.
- 23) To borrow if needed be, against the security of the assets of the trust or any other kind of security of assets by way of bank overdraft, loan or otherwise as may be necessary for the benefit and objective of the trust. Trust can create equitable mortgage on its property to any bank.
- 24) The Trust can authorise any member of the Trust to procure any asset or property by any means or procedure for the benefit and objective of the trust.
- 25) The Trust by its own means or by authorizing any member of trust can sale/transfer any asset or property to any other trust/individuals.
