

ACT, STATUTES AND MEMORANDUM OF ASSOCIATION (MOA)

1. Background

The Institute for Education, Saraikela, was established in 2014 under the aegis of the Educational and Social Development Trust, a registered non-profit organization dedicated to educational and social upliftment in the tribal and scheduled areas of Jharkhand. The Institute was founded with a vision to provide quality teacher education and professional learning opportunities for students belonging primarily to socially and economically disadvantaged groups (SC, ST, OBC, and EWS).

2. Legal Framework and Recognition

The Institute operates under the Educational and Social Development Trust Act, registered under the Indian Trusts Act, 1882, and complies with the University Grants Commission (UGC) Act, 1956, the National Council for Teacher Education (NCTE) Regulations, 2014, the All India Council for Technical Education (AICTE) Act, 1987, and the Kolhan University Statutes and Ordinances. It adheres to all statutory requirements and guidelines issued by UGC, NCTE, AICTE, the State Government of Jharkhand, and Kolhan University.

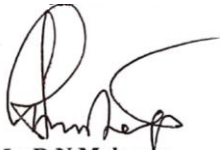
9. Amendments
